Tennessee Immunization Information System (TennIIS)

What is TennIIS?

TennIIS is a statewide immunization information system (IIS) that helps health care providers and schools ensure Tennessee residents of all ages are properly immunized. TennIIS also serves as the online Vaccine Ordering Management System (VOMS) for Vaccines for Children (VFC) providers.

TennIIS is managed by the Tennessee Department of Health. It is a free, secure, and easy-to-use online record of vaccinations received in Tennessee.



Benefits to Health Care Providers

- Provides a consolidated immunization record for new and existing patients, even if a patient has seen multiple health care providers
- Assists with vaccine management and ordering for VFC providers
- Reduces unnecessary paperwork and missed opportunities to vaccinate
- Uses clinical decision support tools to forecast upcoming vaccines due
- Helps comply with administering Advisory Committee on Immunization Practices (ACIP) recommended vaccines and schedules
- Capable of electronic data exchange with electronic health records (EHRs) to avoid double data entry
- Generates data needed for Healthcare Effective Data and Information Set (HEDIS) reporting, vaccine usage reports, and coverage rates for your practice
- Eases the burden on office staff by generating reminders/recall notices for currently-due or past-due vaccines

Benefits to Parents and Patients

- Produces a complete, official immunization certificate for Tennessee school and daycare enrollment
- Assists with identifying missing immunizations
- Prevents unnecessary immunizations
- Helps public health prevent and control disease outbreaks
- No more lost records or trying to remember dates and vaccines
